- 4. Aphorism 225 deals with Psychosomatic illness which of Emotional illness in origin. Caused by Continued Anxiety, Worry, Vexation, Wrong and the frequent fear and Fright [2].

Somatic symptom and related disorders are characterised by prominent Somatic symptoms associated with significant distress and impairment. The Somatic Symptoms may be multiple, vague and involve single or multiple body systems. These Symptoms Often have a Significant adverse effect on the well-being and functioning of the individual and lead to excessive and inappropriate use of healthcare resources. These Somatic Symptoms Are believed to have a Psychogenic Origin ^[3, 6].

Somatic symptoms and related disorders include

- 1. Somatic Symptom Disorder.
- 2. Illness Anxiety Disorder.
- 3. Conversation Disorder.
- Psychological factors affecting other medical conditions.
- 5. Factitious Disorder.

Psychological factors affecting other medical conditions.

Physical disorders caused by or aggravated by psychological factors. It is known factors that the stress can cause many Somatic Symptoms.

Hans Selye describes a model of stress called General Adaptation Syndrome. According to this model, the body reacts to stress in 3stages. They are

- **a)** The Alarm Reaction It is the immediate response characterised by a fight or flight response. It is mediated by Sympathetic Nervous System [10].
- b) The stage of Resistance It is also known as the stage of adaptation. In this stage, the body adapts to stress. ACTH axis I.e hormonal responses is increased in activity. ACTH is secreted into the blood stream by certain cells in the pituitary gland. The rate of ACTH Secretion is, in part, controlled by another hormone like chemical substances like Corticotropin releasing factor (CRF) that is made by certain cells of hypothalamus. This CRFflows from the hypothalamus to the pituitary gland through a specialized system of blood vessels. This ACTH stimulates cells in the outer layers of cortex thus cortisol are secreted into the blood stream [10].
- c) The stage of Exhaustion If the stress continues, the

body's resistance gradually decreased and Finally body collapses. Due to action of cortisol, person may no longer be able to ward off infections and may become sick. Because of the stressor induced hormonal effects, stomach ulcers, diabetes, skin disorders etc., may occur in this stage or late in the stage of resistance [10].

The term Psychosomatic (mind- body) disorders is used when perceived stressors, mental events, increase the Susceptibility of the body to disease [10].

Organs or systems affected—psyhosomatic disorders Examples include

- **A.** Gastrointestinal System Such as Peptic Ulcers, Crohns disease etc. [9],
- **B. Respiratory System** Plays a important role in Asthma, COPD etc.,
- **C.** Cardiovascular System Hypertension, CAD, Cardiac Arrhythmias [9].
- D. Musculoskeletal System Rheumatoid Arthritis, SLE etc..
- **E.** Other disorders are Endocrinological disorders ^[9].

Somatoform Disorders: Physical Symptoms without Physical Cause $\[^{[9]}\]$

A Condition in which an individual has a history of many Physical Complaints, beginning before age thirty, that occur over a period of years and result in treatment being sought for significant impairments in social, occupational, or other important areas of life.^[9]

The Patients with complaints of itching with scaling of skin and sometimes with joint involvement and the causative factor is mainly of Psychological in origin I.e., Suppressed emotions, Suppressed Anger, Financial crisis etc.,

Selection of Tools

A Retrospective study carried out in of Sarada Krishna Homoeopathic Medical College and Hospital. The data collected through case taking. Cases recorded and analysed and the totality erected based on the Miasmatic criteria of patient. Thereby the homoeopathic remedy selected based on totality of patient. Repertorisation is done whenever needed. Prescription was based on Homoeopathic philosophy in all the cases Psychosomatization factor
